## **CLOSED STATE ISSUES ON PRIOR RELEASES**

#### Alabama

**18-7.1F** We modified Form 65, Page 5, Schedule P for the print overlap issue.

#### California

- **18-7.5F** We modified the Column C statement on Form 568, line 11b to include both details.
- **18-7.5F** We now prevent the e-file reject related to Form 568, Side 4, Schedule B, line 23.
- **18-7.1F** We updated the Schedule R Side EIN to print correctly.

#### Connecticut

18-7.1F We updated the e-file validation error related to Form CT-AB, Page 2 if all partners are corporations.

#### Florida

**18-7.7F** We added a force print option for Form F-1065, Page 2, Part IV.

#### Louisiana

18-7.5F We updated print for the Form 565 Schedule D statement.

#### **New York**

**18-7.8F** We now include a downloadable file used to file the individual partners' estimated taxes (IT-2658) on the New York web site. Locators with more than 100 partners included in the IT-2658 must use the bulk file to file. Note that CT-2658 for corporate estimated taxes is still paper filed and is not included in the bulk filing.

#### North Carolina

18-7.1F We modified the calculation on Form D-403, Page 2, Part 2B, line 1 Within NC.

#### West Virginia

**18-7.7F** We now automatically trigger the **Common State** spreadsheet field related to composite when applicable.

**18-7.7F** We added an Organizer override field for Schedule A, line 13.

**18-7.1F** We resolved the issue where the client could not e-file Schedule SP.
